DRILLING PROGRESS REPORT - E1 DEPOSIT

Latest assay results from Mt Margaret Project, E1 Deposit include:

- ❖ 65m at 2.55% copper and 0.56 g/t gold from 44m in EMMD004, including
 - o 9m at 4.28% copper and 0.65 g/t gold from 44m, and
 - o 25m at 3.78% copper and 0.9 g/t gold from 84m
- ❖ 65m at 1.27% copper and 0.35 g/t gold from 121m in EMDT203

And results for the first hole at the Hazel Creek, Turpentine Deposit (no other holes yet received)

- ❖ 16m at 2.94% copper and 0.59 g/t gold from 24m in EHRC181, including
 - o 8m at 4.28% copper and 0.82 g/t gold from 30m

Work is continuing on interpretation of these results for planning of a further program of geophysics and drilling that is due to start at El next week. This program is designed to further delineate the high-grade zones and produce a mining reserve estimate for the first stages of the open pit mining model.
