## **TRANSFIELD SERVICES INFRASTRUCTURE FUND (TSI)**

We advise as follows:

### **A. INTERIM DISTRIBUTION: RECORD DATE AND PAYMENT DATE**

Record Date for TSI Interim Distribution will be 31 December 2009; and

Payment Date for TSI Interim Distribution will be 31 March 2010.

### **B. ESTIMATED INTERIM DISTRIBUTION**

TSI announces an estimated Interim Distribution guidance for the six month period ending 31 December 2009 in the order of 6 cents per stapled security.

The actual Interim Distribution will be announced on 22 February 2010 as part of the release of TSI's results for the half year ending 31 December 2009.

### **C. DISTRIBUTION REINVESTMENT PLAN (DRP)**

Eligible securityholders will again have the opportunity to participate in the DRP for the Interim Distribution. To be eligible, securityholders must have a registered address in Australia or New Zealand and be registered holders of TSI stapled securities on the Record Date, 31 December 2009.

If you wish to participate in the DRP for the interim distribution year ending 31 December 2009 (or if you wish to vary your current level of participation or withdraw from the DRP) your Election Form must be received no later than 9 March 2010. That Election Form will continue to apply to future distributions unless you subsequently vary your participation or withdraw from the DRP. Election Forms received after 9 March 2010 will participate from the next distribution.


A discount of 5% will apply to stapled securities issued under the DRP, calculated with reference to the daily volume weighted average market price per stapled security for stapled securities sold on ASX during the 10 day trading period which commences on 10 March 2010 to 23 March 2010.
