### **Lemur Resources Limited increases to 44.33%**

Bushveld Minerals Ltd ("**Bushveld**" or the "**Company**") is pleased to announce that it now has voting power in Lemur Resources Limited ("**Lemur**") (LMR: ASX) of approximately 44.33%.

This large increase in voting power from 16.77% is largely due to the acceptance by Lemur shareholders whose shareholdings were released from escrow on 24 August 2013.

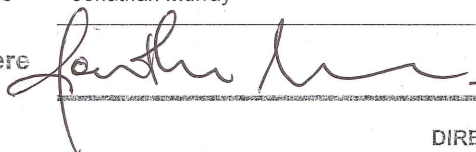

## DIRECTIONS
