# MAJOR POLYMETALLIC DISCOVERY GREATLY EXPANDS POTENTIAL OF THE BATU PERAK SYSTEM

- LWD 358 intersected strongly mineralised polymetallic breccia 160 metres thick
  - Grades average 1.22 g/t Gold Equivalent<sup>1</sup> + 2.3% Base Metals over 160m
  - o Silver-rich cap grading 229 g/t Silver over 13m
- Exceptional drill intersection continues sequence of highly encouraging results
- LWD 358 ended in mineralisation and is open in lateral directions and at depth
- Drilling continues to expand significant potential of Batu Perak prospect

Robust Resources Limited ('Robust' or 'the Company') is pleased to announce assay results from diamond drill hole LWD 358 at the Batu Perak prospect within the Lakuwahi Caldera prospect on Romang Island, Indonesia.

LWD 358 was drilled as part of a series of holes designed to explore the extensive stratabound Volcanogenic Massive Sulphide (VMS) target at Batu Perak. The hole encountered a large and strongly mineralised polymetallic breccia, at least 160 metres thick. The hole has an upper silver-rich cap, and deeper in the hole there are gold and base metal rich zones.




Figure 1: Major Mineralised Polymetallic Breccia Discovery, Drill-hole LWD 358 at Batu Perak. Range rings show that this hole is relatively isolated and therefore a large potential for further discovery is inferred. Holes nearest to LWD 358 are all strongly mineralised

The polymetallic breccia is located 250m to the south-east of the VMS system (Figure 1), and the expected geological relationship between the two will be determined through follow-up drilling.

The LWD 358 hole represents another very significant intersection on Romang Island and also features mineralisation that started at shallow depth of 6.3m and ended in mineralisation at a final depth of 166.7m. The breccia zone is open substantially in all lateral directions and at depth.

The results from LWD 358 include:

- o 160.4m at 1.22 g/t AuEq<sup>1</sup> and 2.3% combined base metals from 6.3m (0.61 g/t Au, 32 g/t Ag, 0.10% Cu, 1.25% Pb, 0.96% Zn) including silver-rich zone:
- 13m at 5.02 g/t AuEq and 1.42% combined base metals from 22m
   (0.69 g/t Au, 229 g/t Ag, 0.03% Cu, 1.36% Pb, 0.03% Zn) and including gold-rich zone
- o 22m at 1.89 g/t AuEq and 4.04% combined base metals from 65m (1.10 g/t Au, 42 g/t Ag, 0.21% Cu, 2.43% Pb, 1.39% Zn)

Refer to Table 1 for the collar details for LWD 358 and a complete summary of the mineralised intersection is located in Table 2.

Robust's Managing Director Gary Lewis commented: "Hole LWD 358 is one of the most significant intersections encountered to date within the Lakuwahi Caldera prospect. The current interpretation is that it is part of the feeder system for the exhalative VMS-style mineralisation currently being explored at Batu Perak.

The continuous grades over a very long interval means that this breccia is a new target in itself with significant discovery potential.

"These results follow on from a particularly encouraging program of exploration drilling, transforming the world-class potential of this project on Romang Island. The processing focus has now moved towards researching the optimum flowsheet to treat the large polymetallic deposits that are currently being delineated.

"Robust continues a very active exploration program on Romang Island with eight owner-operated rigs turning across the Batu Perak VMS and breccia targets, the Batu Mas Deeps high-grade massive sulphides, the exciting silver discovery at Batu Putih and the Batu Hitam basin flats.

"We look forward to updating shareholders with additional results anticipated in the coming weeks."

#### **About Robust**

Robust Resources is a multi-commodity resource company engaged in the exploration and development of precious and base metals in Indonesia, the Kyrgyz Republic and the Philippines. It holds a 70.5% managing interest in the Romang Island polymetallic and manganese projects in Indonesia. In January 2012, the Company published a mineral resource estimate for work completed on Romang Island to the standards set out in the JORC code 2004. The Romang Island Indicated Mineral Resource totals 750 thousand ounces gold equivalent and 737 million pounds of base metals and the Inferred Mineral Resources totals 364 thousand ounces gold equivalent and 733 million pounds of base metals (see Appendix 1 for details).

Since the completion of the above JORC (2004) mineral resource estimate in January 2012, , Resource Robust has completed additional drilling totaling over 17,000 metres and over 200 holes with consistent positive results. The Company is currently working on a updated mineral resource estimate which will be completed under the JORC (2012) guidelines. It is anticipated that this resource estimate will be completed by January, 2014.

Robust holds 80% of the Andash project in the Kyrgyz Republic. Published JORC (2004) Ore Reserves are 540 thousand ounces of gold and 140 million pounds of copper (see Appendix 1 for details).

Robust recently signed an agreement to earn-in a 70% interest in Bashkol copper-gold project in the Kyrgyz Republic.

Robust's dual focus is to become a significant low cost precious and base metal producer on Romang Island and Andash as well as continuing its positive record of new discoveries from its portfolio of exploration properties. Robust trades on the Australian Securities Exchange (ASX) under the symbol ROL.

The metal prices thus used in the calculation are the average Gold price of USD \$1638.39 per ounce and average Silver price of USD \$31.05 per ounce. Metallurgical flotation test-work has been carried out on polymetallic sulphide mineralisation similar to the material reported herein. High recoveries of all metals, including gold and silver, have been achieved in these tests and recovery levels of all metals are similar.(refer to Robust ASX announcement of November 30, 2010 titled "Sulphide Metallurgical Tests Return Exceptional Recoveries of Base and Precious Metals from Romang Island".) For that reason it not considered necessary to apply metallurgical recovery factors in the formula for calculating gold equivalent. In the opinion of the Company that all elements included in the metal equivalent calculation have a reasonable potential to be recovered and sold. This statement on metal equivalents also applies to the Robust ASX announcement of 18<sup>th</sup> September titled "Large VMS-Style Discovery Transforms Development Options On Romang Island"
