The Board of Ensogo Limited (ASX:E88) ("the Company") wishes to provide the following update to the market.

Appendix 4C

Higher than projected cash used in operating activities for the period was driven by two extraordinary expense items. As part of the liquidation process for PT. LivingSocial, the former Indonesian operating subsidiary, Ensogo Limited was informed that the Indonesian Tax Office had determined the entity had an outstanding tax obligation of IDR 2,871,105,229. In order to facilitate the ultimate striking off of the entity, Ensogo Limited paid this obligation in July 2018 which amounted to AUD 274,299. A second extraordinary expense for the quarter involved the renewal of Ensogo Limited's insurance coverage which amounted to AUD 94,930. Together these expenses account for approximately 75% of the total expenditure during the period.

Future direction of the Company

The Company continues to fund the wind up activities of its former South East Asian operating subsidiaries while pursuing specific opportunities which may lead to reinstatement of its listed status. If the latter is unavailable a return of the remaining capital to shareholders via members' voluntary liquidation remains an option.
