### General Meeting Update – COVID-19 Precautions and Voting Details Update

Australian Whisky Holdings Limited (ASX: AWY) advises due to the Australian Government's recent update to restrictions on most indoor gatherings to 2 people, Shareholders will no longer be able to physically attend the AWY General Meeting (GM) scheduled for Wednesday, 15 April 2020 at 11.00am.

Shareholders are advised that the GM will now be held in a complete virtual format via a live webcast with strictly no Shareholder attendance. There will be no formal Company presentation, only the formal matters of the meeting.

The GM will be made accessible to Shareholders to participate through a live webcast via Zoom Conferencing. Shareholders wishing to participate will be required to register their attendance with the Share Registrar before the start of the meeting. Registered Shareholders will be provided with the provision to ask questions in relation to any item of business and also cast their votes on the proposed resolutions.

It is requested that any questions from Shareholders be provided to the Company Secretary (details below) by close of business Tuesday, 14 April 2020. Minimal questions will be taken during the conduct of the GM so that the meeting can be held in an efficient manner.

To enable an efficient virtual meeting, we **strongly encourage** all shareholders to lodge their votes via the Company's share registry platform prior to 11.00am on Monday 13<sup>th</sup> April 2020. We further encourage all shareholders to submit their questions to the Company Secretary prior to the meeting rather than during the virtual meeting.

Shareholders who intend to join the webcast (particularly those intending to vote and have not submitted a proxy) are asked to dial-in 30 minutes prior to the start of the GM to allow the Company's Share Registrar to take your details.
