Trading – Cash Markets (including equities, interest rate and warrant trades)

- In May 2023, the average daily number of trades was down 32% on the pcp. The average daily value traded onmarket of \$5.232 billion was down 20% on the pcp.
- Volatility (as measured by the average daily movement in the All Ordinaries Index) was 0.5% in May, down 0.5% on the pcp.
- Future volatility (as measured by the S&P/ASX 200 VIX) in May was an average of 12.4, down 28% on pcp.
