1 CORPORATE GOVERNANCE

This Corporate Governance Statement describes Metcash Limited's (**Metcash** or the **Company**) corporate governance framework and its governance practices for the financial year ended 30 April 2023 (the **Reporting Period**). These arrangements are consistent with the 4th edition of the ASX Corporate Governance Council's Corporate Governance Principles and Recommendations (**Recommendations**), unless otherwise indicated below.

This Statement is current to 30 April 2023 and has been approved by Metcash's board of directors (Board).

CORPORATE GOVERNANCE HIGHLIGHTS

FY23 Corporate Governance Highlights:

- Board renewal: Metcash has continued its process of Board renewal, to continually ensure the Board has the appropriate breadth and depth of skills, knowledge and industry experience relevant to Metcash for the benefit of shareholders and other stakeholders, appointing a new non-executive director, Mark Johnson, in the Reporting Period in August 2022, who brings deep financial and accounting expertise to the Board. In addition, after 7 years as Chair of the Board, Rob Murray stepped down and was replaced by Peter Birtles.
- Safety and Sustainability Committee: Metcash has established this new Board Committee, effective from 1 May 2023, to assist the Board to discharge its responsibilities in respect of Metcash's safety, environmental and sustainability strategies, policies and practices.
- Technology Advisory Working Group: Metcash has established a new Board working group, effective from 1 March 2023, to provide support and guidance to senior management, and to assist the Board to discharge its duties and responsibilities, in respect of Metcash's technology strategies, policies and practices.
- Culture, engagement and leadership: Metcash has continued its commitment to building a constructive culture to achieve its purpose. The culture and engagement diagnostic is in year two, with the tool measuring both the shorter-term focus on engagement, along with the longer-term measure of culture. The diagnostic is aligned to the leadership development programs that Metcash has in place, which build self-awareness in leaders on their thinking styles and behaviours.
- ESG: Metcash has continued to increase its focus on ESG initiatives in FY23, including deepening and broadening its TCFD and anti-slavery programs and preparing for our first sustainability report written with reference to the GRI reporting standards.
- Managing risk: Metcash has continued to strengthen its risk management framework, including by enhancing and
 maturing its Risk Appetite Statement and Business Resilience Policy and Framework, and regularly reporting to senior
 management and the Audit, Risk and Compliance Committee (ARCC) on material business risks and performance
 against Risk Appetite.
- Strategy and professional development: The Board undertakes regular strategy and professional development sessions outside of Board meetings, including conducting workshops and deep dives into particular topics. In FY23, topics covered included cyber security and privacy, science-based targets and net-zero pathways, work health and safety, artificial intelligence, inclusive leadership, capital management and legislative updates.
- Safety: Metcash undertook a review in FY22 of the management and governance of work health and safety and in FY23 has implemented (and is continuing to implement) various initiatives in response, including uplifting work health and safety reporting, developing detailed mitigation plans for Metcash's top 10 critical Safety, Health and Environment (SHE) risks, undertaking a comprehensive review and update of Metcash's SHE Management System prioritising alignment to legislation, ISO Standards and the top 10 critical risks, and developing a notification and management process for all types of incidents relevant to the business, including SHE incidents.

Anti-bribery and Corruption

The Code of Conduct also covers anti-bribery and corruption matters. The ARCC is informed of any material breaches of anti-bribery and corruption requirements under the Code of Conduct.

Speak Up Policy and 'See Something Say Something' Guidelines

Metcash values speaking up and aims to promote a workplace in which everyone feels safe, supported and encouraged to speak up about any behaviour, conduct or matters that are inconsistent with Metcash's expected standards of conduct and behaviour. The Metcash Speak Up Policy encourages all employees and non-employees covered by the Policy to report suspected 'Reportable Conduct' that they may become aware of during their engagement with Metcash. The ARCC is informed of any material incidences reported under the Policy.

In addition, Metcash adopted in the reporting period 'See Something Say Something' Guidelines. These guidelines were implemented to support team leaders and members to build a constructive culture, supporting a safe work environment and wellbeing of our team members. These guidelines provide guidance to ensure our people know how to raise concerns and complaints safely, with a contact available in each location.

The People and Culture Committee (**P&CC**) monitors cases of harassment (including sexual harassment) and bullying and any workplace matters that result in legal proceedings.


Securities Trading Policy

Metcash has a Securities Trading Policy to assist directors and team members to comply with their obligations under the insider trading prohibitions of the Corporations Act and to protect the reputation of Metcash, its directors and team members.

The Policy also prohibits directors, certain senior executives and other specified personnel from using any derivatives or other products which operate to limit the economic risk of any Metcash securities which they hold that are unvested or subject to a holding lock, as these products can have the effect of distorting the proper functioning of time and/or performance hurdles under executive or employee incentive plans and reduce the intended alignment between management and shareholders.

- the People and Culture Committee and Nomination Committee were combined into one Committee, the People, Culture and Nomination Committee.

From time to time, additional (but non-standing) Board committees or working groups are established or a Board member is appointed as the Board's representative on management steering committees, for example, to consider and oversee or to enhance the Board's oversight of material transactions or projects.

2 OUR BOARD OF DIRECTORS CONTINUED

THE ROLE OF THE BOARD

Metcash is governed by a Board comprising directors who are elected by the shareholders with the exception of the Group Chief Executive Officer (**Group CEO**) who is appointed by the Board.

The Board recognises its overriding responsibility to act honestly, fairly, diligently and in accordance with the law in serving the interests of Metcash's shareholders and our stakeholders which include our team members, customers, suppliers and the community. The directors work to promote and maintain an ethical environment within Metcash that establishes these principles as basic guidelines for all of its team members and representatives at all times.

The Board has adopted a Board Charter which sets out the purpose, role and responsibility of the Board and its relationship with management. The Board is responsible for Metcash's purpose and values and setting its strategic direction, financial objectives, risk appetite and for overseeing and monitoring its businesses, affairs and risks. The Board reviews and approves the Group's strategic and business plans and guiding policies.

Key elements of the Board's roles and responsibilities are described in the diagram below.



DIRECTOR NOMINATION AND SUCCESSION

The Nomination Committee¹ is responsible under its Charter for:

- reviewing and making recommendations to the Board regarding non-executive director retirement and succession (including the Chair);
- establishing and overseeing processes for the appointment and re-election of non-executive directors; and
- evaluating the balance of skills, knowledge, experience, independence and diversity on the Board and, in light of this evaluation, considering whether the composition of the Board remains appropriate, preparing a description of the role and capabilities required for a particular non-executive director appointment and proposing candidates for consideration.

When a vacancy exists or is pending, or when it is considered that the Board would benefit from the services of a new director with particular skills, the Nomination Committee selects from a panel of candidates with appropriate expertise and experience. This may be supplemented with process support from external providers if necessary.

Appropriate background checks of a potential candidate are performed before the candidate is appointed by the Board or recommended to shareholders for election. Where appropriate, external providers may be engaged to assist in undertaking relevant checks.

Prior to directors seeking election or re-election at an annual general meeting, Metcash provides shareholders with all material information known to the Board and relevant to a decision on whether or not to elect or re-elect that director in the notice of annual general meeting.

All directors have entered into written agreements with Metcash, which set out their duties and responsibilities.

DIRECTOR INDEPENDENCE

The Board comprises a majority of independent directors and an independent non-executive Chair.

The Board considers a director independent where they are free from any interest, position or relationship which may interfere, or might reasonably be seen to interfere, with the director's capacity to bring an independent judgement to bear on issues before the Board and to act in the best interests of the entity as a whole rather than in the interests of an individual shareholder or other party.

An assessment of the independence of each director was completed at the conclusion of the 2023 financial year. Materiality, for the purpose of considering whether a director is an officer of or associated with a supplier or customer in a material business relationship with Metcash, is assessed as supplying 2.0% or more of the Metcash Group's annual purchases or purchasing 2.0% or more of the Metcash Group's annual sales. Following this review and as at the date of this Statement, the Board consisted of seven directors, six of whom are non-executive, and all six of whom are considered to be independent directors (being Peter Birtles, Margaret Haseltine, Christine Holman, Murray Jordan, Helen Nash and Mark Johnson).

Any association between a director and an entity with whom Metcash has a business relationship is disclosed in the Company's financial report each year. Each of Mr Birtles, Ms Haseltine, Ms Holman, Ms Nash and Mr Johnson as at the date of this Statement held positions in companies with which Metcash has business relationships. However, the Board has considered each case separately and, having regard to the nature and value of the business relationships, has concluded that these positions do not influence their respective capacity to exercise independent judgement or their ability to act in the best interests of Metcash and its shareholders. None of these directors is involved in any Board decision-making regarding the companies with which they have an association.

BOARD SKILLS MATRIX

INDUCTION AND PROFESSIONAL DEVELOPMENT

Metcash has in place a program for inducting new directors and an annual professional development program to support the directors in maintaining the skills and knowledge needed to perform their role as directors effectively. The professional development sessions include workshops and deep dives into particular topics. In FY23, topics covered included cyber security and privacy, science-based targets and net-zero pathways, work health and safety, artificial intelligence, inclusive leadership, capital management and legislative updates.

INDEPENDENT ADVICE

The Board has a policy of enabling directors to seek independent professional advice at the Group's expense. The Board will review in advance the estimated costs for reasonableness but will not impede directors from seeking advice.

PERFORMANCE REVIEWS AND EVALUATION

The directors undertake an annual process to review the performance of the Board, its committees and individual directors, alternating each year between an internal self-evaluation and an external independent review conducted by a recognised Board performance consultant. In FY23 an external independent review was conducted, and recommendations arising from that review will be actioned in FY24.

The annual review of the Board evaluates a number of areas including:

3 BOARD COMMITTEES

As at the date of this Statement (30 April 2023), the Board had established three standing committees and delegated to each committee duties to assist the Board in exercising its responsibilities and discharging its duties. As noted above, effective 1 May 2023 the Board has also established a Safety and Sustainability Committee and combined the People and Culture and Nomination Committees into one committee.

Each standing committee has a separate charter that sets out the roles and responsibilities of that committee, as well as the membership and any other requirements for the running of the committee. All committees are chaired by and comprise a majority of independent non-executive directors. Each committee regularly reports to the Board on all matters relevant to the committee's role and responsibilities.

4 MANAGEMENT

APPOINTMENT

Appropriate background checks are conducted before a senior executive is appointed.

All senior executives have entered into written agreements with Metcash, which set out their rights, duties and responsibilities.

PERFORMANCE REVIEWS AND EVALUATION

On an annual basis, the P&CC reviews the performance of the Group CEO against qualitative and quantitative criteria, which include profit performance, other financial measures, behaviours and achievement of the Group's strategic objectives. The Group CEO's performance was reviewed in accordance with this process in FY24 in respect of his FY23 performance.

The Company maintains a performance evaluation process which measures other senior executives against previously agreed Strategic Objectives, Key Measures and Performance Targets in a balanced Business Scorecard format, as well as assessing Behaviours. The Scorecards for the Group CEO and all senior executives are made available to the Board quarterly for progress review. Each senior executive reviews their progress against their Scorecard progressively through the year with a formal annual performance evaluation occurring following the year end. Senior executives' performance was reviewed in accordance with this process in FY24 in respect of their FY23 performance.

Senior executives also agree Personal Career and Development Plans to update and enhance their skills and knowledge and, as with the Board, are participating in a key leadership development program, using the LSI tool, which commenced in FY21 and continued through FY23.

REMUNERATION

The Group's remuneration policy is summarised in the 'Remuneration Report' contained within the Directors' Report in our Annual Report. Details of the compensation of Key Management Personnel are also contained in the Remuneration Report.

COMPANY SECRETARY

The company secretary is appointed and removed by the Board and reports to and is accountable to the Board, through the Chair of the Board, on all matters to do with the proper functioning of the Board and Board committees. Further details on the company secretary are provided in the 'Board Information' section of the Directors' Report in our 2023 Annual Report at page 47.

5 SHAREHOLDERS AND REPORTING

MARKET DISCLOSURE

Metcash is committed to effective communication with its customers, shareholders, market participants, employees, suppliers, financiers, creditors, other stakeholders and the wider community. The Board has adopted a Market Disclosure Policy which has established procedures designed to ensure compliance with ASX Listing Rule and Corporations Act disclosure requirements.

Where practicable, the Board approves all material ASX announcements before they are lodged with the ASX and receives copies of all announcements after they have been released by the ASX.

COMMUNICATION WITH SHAREHOLDERS

Metcash has adopted a Shareholder Communications Policy and communicates information to its shareholders and other stakeholders regularly, through a range of different forums and publications, including:

- providing material information and other information about Metcash and its governance via its website at
 www.metcash.com, including copies of its constitution, Board and committee charters, Metcash's statement of values and
 core corporate governance policies;
- enhancing shareholders' ability to participate in the annual general meeting (AGM) process by allowing shareholders
 a reasonable opportunity to ask questions during the AGM and to submit questions prior to the AGM and allowing
 shareholders to lodge proxies electronically. Metcash conducts all voting at the AGM on a poll, ensuring that voting
 outcomes reflect proportionate holdings of all shareholders who vote (whether in person or by proxy or other
 representative);
- conducting briefings with investors and analysts on the Company's financial results twice a year. The Company also
 holds briefings for investors and analysts in connection with strategy days, site tours, investor roadshows and investor
 conferences. Associated presentation materials are released to the ASX ahead of the briefings, and then made available on
 the Company's website; and
- providing up-to-date information about the Company on Metcash's website, including all announcements made to the
 market (other than administrative announcements), annual and half yearly reports, corporate governance policies and
 charters adopted by the Board and its standing committees, investor presentations and copies of notices of meeting and
 explanatory material.

Metcash facilitates two-way communication with investors, with shareholders able to contact Metcash's share registry and the company secretary by phone or email. Shareholders are also able to communicate with directors and senior executives at the AGM which is held at a time and format to maximise the opportunity for shareholders to attend and participate in meetings.

Metcash encourages electronic communication with shareholders to facilitate the quick and environmentally friendly dissemination of information. This is being done through, for example, email, Metcash's website and corporate social media. Shareholders are able to request printed hard copies of publications where they are unable to access them electronically.

INTEGRITY OF CORPORATE REPORTING

Metcash has a process in place to ensure the integrity of its periodic corporate reports that are not audited or reviewed by an external auditor. The process is aligned with Metcash's Risk Management Policy and the three lines of defence.

The preparer of the periodic corporate report is responsible for ensuring material statements are accurate and based on reliable sources of information. The periodic corporate report is then independently reviewed by senior management including to ensure material statements are accurate and stated assumptions or opinions are reasonable. A 'third line' quality assurance check is then completed by either an independent third-party assurance provider or by Metcash's internal audit department.

6 RISK MANAGEMENT

RISK MANAGEMENT FRAMEWORK AND POLICY

The Board is responsible for determining Metcash's risk appetite and monitoring financial and non-financial risks. The Board is supported in its risk oversight role by the ARCC. The role of the ARCC is to assist the Board in discharging its duties in respect of governance, risk management, financial reporting and legal and regulatory compliance.

Metcash's approach to risk oversight and management of material business risks is outlined in our Risk Management Policy, which is available on our website at https://www.metcash.com/corporate-information/corporate-governance/. The ARCC reviews the Metcash risk management framework annually to satisfy itself that it continues to be sound and that Metcash is operating with due regard to the risk appetite set by the Board. In respect of FY23, activities included a review and update of the Company's Risk Appetite Statement, Risk Management Policy, the Business Resilience Policy and Framework, and the Internal Audit Charter. The ARCC also conducted, in early FY24, a review of the Company's FY23 performance against the Risk Appetite Statement to satisfy itself that Metcash is operating with due regard to the risk appetite set by the Board.

ENVIRONMENTAL AND SOCIAL RISKS

Metcash is committed to responsible and sustainable business practices which take into account our own operations and our impacts in the supply chain. This spans consideration of environmental and social risks as well as opportunities. Metcash aligns with the Taskforce for Climate-Related Financial Disclosures and monitors and reports ESG performance annually through participation in the Carbon Disclosure Project, the Global Reporting Initiative, the Dow Jones Sustainability Index and National Greenhouse and Energy Reporting.

The Group has a corporate responsibility function which sits within Corporate Affairs with a direct reporting line to the Group Chief Financial Officer (**Group CFO**). The function considers environmental and social risks within the overall context of the Metcash Risk Management Framework and Guidelines, with additional specific requirements for modern slavery and climate change. The Metcash ESG Council, compromising cross-functional representatives from all pillars and chaired by the Group CEO, oversees ESG-related risks, opportunities and programs of work.

The Operating and Financial Review on pages 36 to 45 of our 2023 Annual Report contains detailed information about Metcash's material business risks, including Metcash's exposure to social responsibility, environmental and climate change risks.

The Sustainability Report provides more detailed information on ESG activities across the areas of Our Planet, Our People, Customers and Community.

INTERNAL AUDIT

The Group has an internal audit function. The head of the internal audit function has a direct reporting line to the Chair of the ARCC and, therefore, to the Board. The internal audit function's role is to provide independent, objective assurance to assist Metcash in meeting its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, control and governance over business processes.

MANAGEMENT ASSURANCES/CERTIFICATION

The Group CEO and CFO provided a declaration to the Board in respect of both the FY23 half year and full year financial statements that:

- the financial records of the Company and its consolidated entities have been properly maintained;
- the financial statements and associated notes for the Company and its consolidated entities comply with Australian Accounting Standards and give a true and fair view of its financial position and performance as at the relevant date and for the relevant period respectively; and
- their opinion was formed on the basis of a sound system of risk management and internal control which is operating effectively in relation to financial reporting risks.

7 DIVERSITY, EQUITY AND INCLUSION

DIVERSITY, EQUITY AND INCLUSION POLICY

Metcash recognises the benefits of a workforce that has a range of skills, backgrounds and experiences. In maintaining a diverse workforce, Metcash seeks to attract and retain the best talent to deliver the best results for Metcash and its shareholders

Metcash's Diversity, Equity and Inclusion Policy applies to all employees, directors and officers of the Metcash Group and sets out Metcash's areas of focus in relation to diversity.

DIVERSITY, EQUITY AND INCLUSION INITIATIVES

Metcash continues to design and implement key strategies and initiatives that drive and support equality and build and support a diverse and inclusive culture to better serve our communities and customers and to continuously promote an environment where our people feel safe, recognised, valued and supported and have a sense of belonging. Key initiatives include:

- Gender diversity continuing our work in the attraction and recruitment, development and connection and acceleration of
 our women. For the fifth consecutive time, we have been recognised as a WGEA Employer Of Choice for Gender Equality.
 This also includes our Remuneration Review where Metcash deploys a robust and market-driven job and remuneration
 framework, which includes specific analysis of gender pay across the organisation by both WGEA levels and Hay job bands,
 to reduce and eliminate pay inequality in like-for-like roles, for existing employees and new hires;
- Cultural diversity creating opportunities to drive engagement with and awareness of our cultural diversity, in particular
 in relation to our LGBTQ+ community and our Aboriginal Torres Strait Islander and Māori and Pacifika communities, by for
 example embedding our symbols of culture through Acknowledgements to Country and Edu-Series to support both our
 Pride and First Nations communities;
- Supporting our communities aligning to charity organisations to drive our engagement in our cultural diversity within our local communities, supported by DEI champions and volunteers;
- Inclusive leadership increasing investment in inclusive leadership development, designed to mitigate bias and encourage diversity of thought and to strengthen the talent pipeline to engage and retain our people and support great careers;
- Diversity, Equity and Inclusion Council members represent pillars and functions across the business, and work to influence, champion and drive diversity, equity and inclusion across the organisation;
- Leadership Development and Talent Acceleration continuing our commitment to leadership development and talent
 acceleration with programs for our top 500 leaders to strengthen leadership capability, including focussing on diversity and
 inclusion: and
- In recognition of demonstrating genuine commitment to workplace flexibility, we have attained FlexReady certification from FlexCareers. Metcash achieved a score of 87%, which surpasses the cohort average of 72%, highlighting the commitment to creating a flexible and inclusive environment.

In FY23, the Board set measurable objectives for achieving gender diversity in the composition of the Board and Metcash's senior executives and broader workforce.
