Norton Gold Fields Limited – Zijin Mining Group Co Limited – Scheme of Arrangement

Description

Shareholders in Norton Gold Fields Limited (the "Company") voted in favour of the Scheme of Arrangement (the "Scheme") giving effect to the merger with Zijin Mining Group Co Limited ("Zinjin"), at a meeting held on 12 June 2015. The Scheme was approved by the Federal Court of Australia on 19 June 2015.

Under the Scheme, shareholders in the Company will receive 25 cents for every fully paid ordinary share in the Company held at the record date.
