Results of Adelaide Bank Scheme Meetings

Adelaide Bank is pleased to advise that its shareholders have voted to approve the schemes of arrangement in connection with Adelaide Bank's proposed merger with Bendigo Bank.

The votes were cast at three scheme meetings held this morning at the Adelaide Convention Centre, Adelaide South Australia.

In accordance with section 251AA of the Corporations Act, information in relation to resolutions passed by members of Adelaide Bank at its Ordinary Share Scheme Meeting, Step Up Preference Share Scheme Meeting and Reset Preference Share Scheme Meeting is set out in the Annexures to this release. All resolutions were passed by majorities comfortably exceeding the required thresholds.

Adelaide Bank will attend at a hearing of the Federal Court on 16 November 2007 to request the Court to approve the schemes. If that approval is granted, the schemes of arrangement are scheduled to be implemented on 30 November 2007.
