During the quarter, the Company, in hand with its consulting geologists Derek Foster & Associates, has developed a drilling program for the Bunnawarra project.

The Company has been advised that recent heavy rain in the area has postponed drilling. To date, drilling lines have been bulldozed to improve access. The field crew remain on stand-by, whereby conditions are monitored regularly with the expectation of drilling to commence shortly.

All further drilling activity will be reported as it comes to hand.
