APPROVAL GRANTED FOR NEW HIP & SPINE IMPLANTS IN AUSTRALIA 'competitive prices can bring down costs'

Orthopaedic implant manufacturer and marketer, Austofix, has gained federal approval to market its hip replacement and spinal 'cage' implant devices* in Australia. The approval expands Austofix's range beyond its traditional products that fix and stabilise fractures and builds on Austofix's strategy of providing "Gold Standard" products.

Austofix CEO, Mark Szolga said the company was pleased finally to be able to offer Australia's orthopaedic surgeons, particularly those operating in the public sector, two "Gold Standard" products that are in high demand and priced to help reduce cost pressures on the health system.

"Our total hip replacement product gives us entry to a \$250m Australian market where Austofix is one of very few manufacturers of orthopaedic devices still remaining in Australia.

"We think our entry into both hip replacements and spinal implants comes at an opportune time, given the current major health debate in Australia. The pressures facing the health system in Australia are complex and large. But providing products that lower the prosthesis cost of total hip replacements is a part of the equation to which we can contribute and so help relieve at least some of the financial pressure on the system.

"Cost and patient outcomes are the focus in orthopaedic surgery and we will be marketing these high-quality new products at prices that, we believe, the public sector will welcome."

Mr Szolga said the company's locally manufactured orthopaedic implant products were steadily gaining acceptance because of their high quality, keen pricing and the provision of implant tools by the company to the surgeons.
