Explanation of Operating Cash Flows for the quarter ending 30 June 2012

CBD has continued to progress its wind developments and international solar projects during the quarter. The day to day operating costs incurred in doing so are reflected in operating cash flows. The Company has also expended \$11.2m in development costs for these projects during the year which are reflected in investing cash flows. Of particular note, the company has finished construction and commissioning of its first Italian solar project of 5 MW. The Company has signed a Term Sheet to sell the project to a British institution, subject to the completion of satisfactory due diligence.

As previously announced, CBD has successfully tendered and won a US\$3.8M solar project in the USA. This project is expected to be completed in the second quarter of the 2013 financial year. The Company has been negotiating several other International solar projects during this quarter and expects to progress these developments in next few months.

CBD's Australian solar business is also undergoing a restructure at present.
