### Alinta Signs \$28 million Gas Transportation Agreement with Energex

Alinta and ENERGEX today announced the signing of an agreement for the transport of gas through Alinta's Queensland Gas Pipeline to the new \$1.4 billion Comalco Alumina Refinery in Gladstone.

The announcement coincides with scheduling of first flows under the agreement to provide for commissioning of the refinery. Alinta will transport more than 4 petajoules\* (PJ) of coal seam methane (CSM) to the Comalco refinery each year, starting upon completion of the refinery in the third quarter of this year

Alinta Chief Executive Officer Bob Browning said the signing signifies the commencement of the first contract for firm haulage on the Queensland Gas Pipeline (QGP) since 1997 and comes less than six weeks after Alinta acquired the asset.

Mr Browning said the access agreement confirmed the growth potential of the QGP and demonstrated how Alinta was determined to work with clients such as ENERGEX to support industrial development in Queensland. The refinery will be one of the largest non-power generation gas consumers in Queensland. The agreement will generate at least \$28 million additional cash flow for Alinta over its ten-year term.

This agreement has involved Alinta installing a new delivery point and associated facilities on the QGP adjacent to the Comalco refinery.

ENERGEX Retail General Manager Mr Andrew Kremor said the agreement with Alinta was the culmination of 5 years of consultation with Comalco and was further evidence of ENERGEX's ability to deliver tailored gas solutions to meet the needs of major industrial facilities.

"Since diversifying into gas with the purchase of Allgas Energy in 1998, ENERGEX has experienced considerable success in sustained growth of its gas business with substantial sales achieved along the eastern seaboard," Mr Kremor said.

ENERGEX will supply the gas from its contracted CSM reserves strategically located along the QGP, which runs from gas fields near Roma, west of Brisbane, to Gladstone and Rockhampton.

Alinta is one of Australia's leading providers of energy-related products and infrastructure solutions, managing, owning or operating \$5.7 billion of assets across Australia and New Zealand.
