On 14 November 2017, a loan facility agreement was entered into between the Company and ASF Group Limited ("ASF"), pursuant to which ASF will provide up to \$1 million unsecured loan facility ("Facility") to the Company for a term of 12 months, at the interest rate of 12% per annum. On 24 September 2018, the Company and ASF agreed to increase the Facility to \$2 million and extend the maturity date to 31 December 2019.
