Performance Rights granted under the Monash IVF Group Limited Equity Incentive Plan (EIP). The EIP was approved by shareholders at the 2017 AGM and a summary of the terms of the EIP were included in the Notice of AGM lodged with ASX on 23 October 2017.

Subject to the EIP terms, each Performance Right granted under the EIP will entitle the holder to be issued, transferred or allocated one share for nil consideration subject to the satisfaction of the relevant vesting conditions.

The final number of Performance Rights that vest will depend upon an assessment of the satisfaction of the performance hurdles during the 3 year performance period from 1 July 2019 to 30 June 2022.

Subject to the EIP terms, unvested Performance Rights granted will lapse where the performance hurdles are not met.
