The Fund will reopen for applications and redemptions by Authorised Participants on 04 January 2021. The above close period arrangements are applicable only for BNDS.

To be eligible, you will need to have purchased your units prior to the Ex Distribution Date, for the transaction to have been settled and for your unitholding to have been entered on the register as of the Record Date.
