VESTING OF PERFORMANCE RIGHTS AND DEFERRED RIGHTS AND EXPIRY OF OPTIONS

Class Limited (*Class* or the *Company*) refers to its announcement today that the scheme of arrangement under which HUB24 Limited (*HUB24*) is to acquire 100% of the issued capital in Class (*Scheme*) is now legally effective as of today (the *Effective Date*).

1. Performance Rights

As contemplated by the Scheme Booklet, 1,701,385 performance rights granted pursuant to the Performance Rights and Deferred Rights Plan (*Incentive Plan*) have converted into ordinary shares in Class and vested on the Effective Date.

Of those 1,701,385 ordinary shares, 566,667 will be cash-settled (so that the recipient will receive a cash payment in lieu of the ordinary share in Class), 67,147 will be transferred to the recipient from existing Class treasury shares, and the remaining 1,067,571 are to be issued as per the attached Appendix 2A.
