This supplementary product disclosure statement ("SPDS") updates the information in the Product Disclosure Statement ("PDS") for the SPDR® S&P/ASX 200 ESG Fund dated 24 July 2020 as amended by the SPDS dated 14 February 2022, issued by State Street Global Advisors, Australia Services Limited (ABN 16 108 671 441) (AFSL 274900).

The purpose of this SPDS is to advise that, with effect from the rebalancing which takes effect prior to market open on 2 May 2022, the index methodology for the SPDR® S&P/ASX 200 ESG Fund will be amended to introduce additional, expanded and revised exclusions, in addition to those detailed on page 18 of the PDS.

The additional exclusions cover Oil Sands, Small Arms and Military Contracting, the expanded exclusions cover Controversial Weapons, and the revised exclusions cover Tobacco.
