



Change in Director's Interest - Geoff Wilson

17 March 2023 ASX announcement

Attached is an Appendix 3Y announcing a change in Director Geoff Wilson's interest in WAM Leaders Limited ordinary shares acquired. On 16 March 2023, Mr. Wilson purchased 54,740 WAM Leaders shares on-market through his superfund Dynasty Peak Pty Limited.

On 15 March 2023, an Appendix 3Y for Mr. Wilson was announced for the on-market sale of 54,740 shares through Awe Superfund which is a family member's self-managed super fund of which Mr. Wilson is a director. The sale of shares is a result of Awe Superfund winding up.

The net movement between the two Appendix 3Ys is nil. As at 16 March 2023, Mr. Wilson holds 12,895,939 WAM Leaders ordinary shares.
