REQUEST FOR TRADING HALT – WAM LEADERS LIMITED

In accordance with ASX Listing Rule 17.1, WAM Leaders Limited (**WAM Leaders**) (ASX: WLE) requests that its securities be placed into an immediate trading halt pending a further announcement in relation to:

- a) a proposed placement to wholesale and sophisticated investors (**Placement**); and
- b) a proposed capital raising to existing shareholders,

and to allow the Placement to take place.
