

## Notice under ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547

This notice is given by WAM Leaders Limited (ACN 611 053 751) (ASX: WLE) (WAM Leaders) under ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547 (ASIC Instrument 2019/547).

WAM Leaders refers to its announcement on 14 April 2023 whereby eligible shareholders will have the opportunity to purchase a parcel of fully paid ordinary shares in the capital of WAM Leaders up to the value of \$30,000 (SPP Shares) under a Share Purchase Plan (SPP).

The SPP will open (and the SPP offer will be made) on 17 April 2023.

WAM Leaders gives the ASX (as the relevant market operator) notice that:

- 1. WAM Leaders will make offers to issue the SPP Shares under the SPP without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (Corporations Act);
- 2. this notice is given in accordance with ASIC Instrument 2019/547;
- 3. as at the date of this notice, WAM Leaders has complied with:
  - (a) the provisions of Chapter 2M of the Corporations Act as they apply to it; and
  - (b) section 674 of the Corporations Act; and
- 4. as at the date of this notice, there is no excluded information (as defined in subsections 708A(7) and 708A(8) of the Corporations Act, as if this notice was a notice under paragraph 708A(5)(e) of the Corporations Act.
