Trading – Cash Markets (including equities, interest rate and warrant trades)

- In June 2023, the average daily number of trades was down 26% on the pcp. The average daily value traded onmarket of \$5.705 billion was down 19% on the pcp.
- Volatility (as measured by the average daily movement in the All Ordinaries Index) was 0.6% in June, down 0.5% on the pcp.
- Future volatility (as measured by the S&P/ASX 200 VIX) in June was an average of 11.9, down 36% on pcp.
