LAST DAY OF TRADING OF ABACUS GROUP SECURITIES ON A DEFERRED SETTLEMENT AND RECONSTRUCTED BASIS

Abacus Group (ASX:ABP to be changed to ASX:ABG on Thursday, 10 August 2023)<sup>1</sup> acknowledges the announcement titled "Settlement of Offer and Satisfaction of Conditions for Conditional Market" released by Abacus Storage King (ASX:ASK) on the ASX today regarding, among other things, that the conditions for Abacus Storage King's conditional market have now been satisfied.

As a result, today is expected to be the last day of trading of Abacus Group securities<sup>2</sup> on a deferred settlement and reconstructed basis.

Trading of Abacus Group securities is expected to commence on a normal (T+2) settlement basis from Monday, 7 August 2023.
