360 CAPITAL GROUP (ASX: TGP) Completion of Minimum Holding Buy-back

Page 1 of 2 360 Capital Group (ASX:TGP) (360 Capital) is pleased to announce that further to the ASX Announcement on Thursday 7 December 2023, it has completed the buy-back of unmarketable parcels of Securities (**Buy-back**). Under the ASX Listing Rules, any parcel valued less than \$500 is considered to be an 'unmarketable parcel'.

In accordance with the terms of the Buy-back, Eligible Security holders had until 5.00pm AEDT on Tuesday 23 January 2024 (**Closing Date**) to opt-out of the Buy-back or increase their holding to a marketable parcel. Eligible Security holders that did not exercise either of these options by the Closing Date had their securities bought back at \$0.53 per security (**Buy-back Price**).

A total of 50,495 fully paid stapled securities from 203 security holders have been acquired under the Buy-back at the Buy-back price and have been cancelled in accordance with the *Corporations Act 2001* (Cth). The number of securities acquired is approximately 0.02% of TGP's total stapled securities on issue.

An Appendix 3H (Notification of Cessation of Securities) will follow this announcement.

The impact of the Buy-back on TGP's capital structure is as follows:

- Number of securities on issue prior to the cancellation of Buy-back securities: 233,921,607
- Number of securities on issue after the cancellation of Buy-back securities: 233,871,112
- Number of TGP's security holders prior to completion of the Buy-back: 2,440
- Number of TGP security holders after completion of the Buy-back: 2,237

In accordance with the requirements of ASX Listing Rule 3.8A, enclosed is a copy of the Form 484 lodged with ASIC recording the cancellation of the securities.

360 Capital is pleased to advise that, as announced on Thursday 7 December 2023, the results of the Buy-back will reduce the ongoing administrative costs of managing small holdings.

Eligible security holders whose securities were bought back under the Buy-back will have their proceeds remitted to them and will be sent documentation advising them of the number of securities bought back and relevant details on or around Friday 2 February 2024.
