### **Weekly NTA Update**

As at market close on 1 March 2024, the estimated net tangible asset (NTA) backing per ordinary share for VGI Partners Global Investments Limited (VG1) was **\$2.07 ex-dividend**, after all applicable fees and charges.<sup>1</sup>

The NTA of \$2.07 is after subtracting the recently announced interim dividend of 5c per share, which had an ex-date of 14 February 2024 and is payable on 18 March 2024.
