Upon vesting following testing at the end of the performance period, performance options will be automatically exercised and the net number of shares will be allocated using the formula described on page 11 of the Myer 2018 Notice of Annual General Meeting.

There is no amount payable by the holder either on grant or vesting and exercise of Performance Options.

There are two performance conditions that apply to Performance Options issued under the Executive Offer:

- 1 50% of the Performance Options are subject to a hurdle based on the compound annual growth rate in the company's earnings per share over a three year period from the beginning of FY2019 to the end of FY2021 (the **Performance Period) (EPS Hurdle)**
- 2 50% of the Performance Options are subject to a hurdle based on the company's total shareholder return ranking over the Performance Period, which will be tested following the end of the Performance Period by comparing the company's total shareholder return over the Performance Period, relative to the total shareholder return of companies in a defined peer group (**TSR Hurdle**).

The EPS Hurdle and TSR Hurdle will be assessed separately and apply to different tranches of Performance Options. This means that both hurdles do not need to be satisfied for any of the Performance Options to vest.

The performance conditions will be tested once at the end of the Performance Period. Any Performance Options which do not vest will lapse.
