Covata Limited (**the Company**) wishes to advise that Covata Chairman and UK resident, Mr Bill McCluggage, has indicated his intention to resign as a director on 31 October 2019.

The Board has resolved that Managing Director and CEO, Mr Ted Pretty, will become Executive Chairman and the casual vacancy will be filled by Mr Graham Mirabito effective 1 November 2019.
