GBM Gold Limited (ASX: GBM) ("GBM Gold") refers to ASX's policy under Guidance Note 33 Section 3.4 which provides that an entity would be removed whose securities have been suspended from quotation for a continuous period of 2 years.

GBM Gold wish to inform shareholders that the Board of Directors had for the past few weeks been in discussion with V-infinity with a view to commence the drawdown of its financing facility. Concurrently the directors have also been in negotiation to finalise a \$10 million investment into the Company.

Early in the week the Company secured the \$10 million investment through a Binding Term Sheet with proof of fund. \$6.7m of the investment would be used to underwrite a 1:1 rights issue to be undertaken by the Company while the balance would be in the form of a Convertible Loan to the Company.

Regretfully the Company was not able to secure from ASX an extension of its listing status beyond the second anniversary of the suspension of trading of its shares to complete the capital raising. As a result and in accordance with ASX policy, the Company shares would cease to be listed on ASX before the start of trading on Tuesday 13 October 2020.

The Board would however continue its efforts to recapitalise the Company with a view to repay its creditors and to resume gold production when working capital is available. It would also seek to relist its shares on a stock exchange in the future.

The Company remains a disclosing entity and subject to continuous disclosure obligations under the Corporations Act. The Company will announce information as required the Corporations Act by as soon as practicable emailing shareholders and publishing announcements on the Company's website www.gbmbendigo.com.au. To receive information, shareholders who have not done so are urged to provide the Company with their email address.
