Answer: The Directors are confident that sufficient funds can be secured if required by combination of capital raising and or sale of financial assets. The Company has an investment in AIM listed Pantheon Resources Plc and has the option to liquidate its position in this investment if there are insufficient funds being generated through capital raisings. As of 30 June 2021, the fair value of the Company's investment in Pantheon Resources Plc was approximately \$4.7 million. During the quarter, the Company sold 200,000 shares in its listed investment Pantheon Resources Plc (Pantheon) to fund general working capital. The consideration for the sale was approximately \$109,990 (before costs). Also, subsequent to the end of the quarter, the Company sold an additional 200,000 shares in Pantheon to fund general working capital. The consideration for the sale was approximately \$192,789 (before costs). The Directors considered that the sale of shares in Pantheon was the most cost-efficient, non-dilutive and expedient method of funding available to it at the time.

Answer: Yes, the Company expects to be able to continue its operations and meet its business objectives on the basis that it expects to be able to secure funding in the future as described in answer to question 8.8.2 above.
