Australian Dairy Nutritionals Group Limited (**AHF** or the **Group**) advises that this activity report relates to the Appendix 4C for the quarter ended 30 September 2023 (**Quarter**) released to the market on 31 October 2023.

### **Quarterly Activity Report (QAR) –for the quarter ended 30 September 2023 (Quarter)**

#### **(a) Details of the Company's Business Activities for the Quarter**

The Group's business activities during the Quarter focussed on dairy farming and dairy manufacturing. The expenditure reported in the Quarter relates primarily to:

- dairy farm operating costs including feed and employment costs;
- infant formula production costs including purchase of raw materials, packaging, employment and other associated manufacturing costs;
- corporate costs in relation to the Group including employment costs, ASX fees, registry fees, insurance and professional fees.

The Quarter also includes proceeds of \$710k in respect of a private placement to sophisticated investors announced on 11 July 2023.

The Board is carefully monitoring the cash position of the Group and is focussed on reducing operational costs as it works to grow domestic and international distribution of its infant formula ranges. In addition, the following initiatives are being progressed to support cash flow requirements:

- a) the Brucknell South dairy farm has been listed for sale through Elders Camperdown (refer to ASX Announcement dated 16 October 2023); and
- b) the Group is in the final stages of negotiation of a secured loan facility.

#### **(b) Payments to an associate of, a related party of the Company (section 6 of Appendix 4C)**

Section 6 of the Appendix 4C reports expenditure of \$68k paid as Director's fees (including superannuation) during the Quarter.

Answer:

The current level of net operating cash flows is expected to continue in the short-term. The Group expects to increase cash flows as domestic sales grow and, it commercialises the sale of its infant formula ranges in overseas markets. Registration of both the Ocean Road Dairies and future Gradulac Gentle ranges is progressing in both Vietnam and Canada.

Answer:

The Board is carefully monitoring the cash position of the Group and is focussed on reducing operational costs as it works to grow product sales. In addition, the following initiatives are being progressed to support cash flow requirements:
