LEGEND EXPANDS IN SUB SAHARAN AFRICA

The Directors of Legend Corporation are pleased to announce that Legend has taken full control of its South African-based joint venture manufacturing and distribution company Memory Performance Pty Ltd.

Memory Performance has been operating for more than five years distributing memory and related components in the sub-Saharan African region. The joint venture operation grew strongly since the initial agreement was struck in late 1999. The manufacturing facilities have now been decommissioned and the equipment shall be relocated to the new Singapore facility. In summary, the terms of the termination agreement were that Legend shall continue to supply memory module products to the former JV partner, Legend paid nominal consideration for the balance of shareholding and the JV company (Memory Performance Pty Ltd) repaid a loan of rand 4,600,000 (AUD\$944,931) to the former JV partner. In the 12 months to February 2005 the joint venture generated revenues of rand 36 million (AUD\$7.2m) and a NPAT of rand 581,546 (AUD\$117,000).

Once fully integrated into the Legend group, Memory Performance Pte Ltd. will benefit from the synergies with the broader Legend global procurement and distribution network enabling the South African operations to deliver considerably better sales revenue and margins than previously achieved under the joint venture. The South African business unit is expected to add AUD\$10 million in additional revenue for financial year 2006.

The South African distribution operations will continue with reduced local staff under the leadership of Mr Robert Carlton, a founding team member of the South African JV. Strategic support will be provided from the existing Australian and Legend's soon-to-be launched Singapore operation. Legend in South Africa will now share the same systems, processes and manufactured products as Australia and New Zealand.

As previously indicated, Legend has targeted total revenue to increase to \$205 million in the 2006 financial year (up more than 20% from the forecasted 2005 financial year revenue of \$170 million) with margins similar to those currently being achieved.
