# SAN JORGE LITHIUM BRINE PROJECT - UPDATE

Further to the announcement dated 26 March 2021, Bass Metals Ltd (**Bass** or the **Company**) advises that the conditions precedent period for the acquisition of Blackearth SA (**Blackearth**), a company incorporated in Argentina which holds an option to acquire the San Jorge Lithium Brine Project located in Catamarca province, Argentina, has been extended by mutual agreement.

Bass is progressing with its due diligence, one of the conditions precedent, however due to COVID-19 restrictions in place in Argentina, the Mining Department of the Province of Catamarca has been closed since mid-May and currently remains closed until at least 6 June 2021. As a consequence, Bass has been unable to complete due diligence enquires on the status of the relevant mining tenements.

The due diligence period has been extended to 21 June 2021.
