## SCHEME BOOKLET DISPATCHED

Oklo Resources Limited ("**Oklo**" or "**the Company**") refers to its announcements released on 29 July 2022 regarding the proposed acquisition of Oklo by B2Gold Corp. ("**B2Gold**"), through its wholly owned subsidiary, B2Gold Oklo Resources Pty Limited, pursuant to a scheme of arrangement ("**Scheme**") and confirms that the scheme booklet which includes an explanatory statement providing information about the Scheme ("**Scheme Booklet**") was yesterday dispatched to Oklo shareholders, including the relevant notice of Scheme Meeting, personalised proxy form and small shareholder election form.

Oklo shareholders who have not made an election on how to receive communications will receive a letter (sent by post) containing instructions about how to view or download a copy of the Scheme Booklet, together with their personalised proxy form and small shareholder election form.

### SCHEME MEETING

The meeting of Oklo shareholders to consider and, if thought fit, approve the proposed Scheme ("**Scheme Meeting**") will be held at Thomson Geer, Level 14, 60 Martin Place, Sydney NSW 2000 at 10:00am (AEST) on Thursday, 1 September 2022. The Scheme Meeting will be held in person and electronically via an online platform.

Details of how to access the online platform and participate in the Scheme Meeting are contained in the notice of Scheme Meeting included in the Scheme Booklet. Oklo shareholders who participate in the Scheme Meeting via the online platform will be able to listen to the Scheme Meeting, cast a vote online and ask questions.

All registered Oklo shareholders as at 7:00pm (AEST) on Tuesday, 30 August 2022 will be eligible to vote at the Scheme Meeting.

All Oklo shareholders are encouraged to vote either by attending and voting at the Scheme Meeting in person or online or by lodging a proxy to attend and vote at the Scheme Meeting. The Scheme Booklet provides information on how to lodge your proxy form.
