- 50% of the granted performance rights will be subject to a vesting condition based on Relative Shareholder Return, whereby the Company's TSR must be greater than the TSR of 70% of the peer group of 10 companies over the performance period commencing on 1 July 2022 and ending on 30 June 2025. This vesting condition can only be met if the Company's TSR is positive.
