## **EXPIRY OF LISTED OPTIONS (ASX: HTGO) – REVISED**

Further to the announcement on 8 March 2024, Harvest Technology Group Limited (ASX:HTG) (Company) provides a revised announcement below showing a revised date that the options will cease trading of Thursday, 28 March 2024.

Harvest Technology Group Limited (ASX:HTG) (Company) wishes to advise that 45,186,832 quoted options, exercisable at \$0.25 each (trading under ASX code HTGO) (Options) will expire at 5pm (WST) on 7 April 2024 (Expiry Date).

Official quotation of the Options on ASX will cease at close of trading on Thursday, 28 March 2024, being four business days before the Expiry Date.

The Company notes that the Options are substantially "out of the money" and advises that it will not be dispatching personalised notices to option holders in accordance with Item 5.3 of Appendix 6A to the Listing Rules.

In accordance with Item 5.2 of Appendix 6A, the Company provides the following information to holders of the Options:

- 1) the total number of Options on issue is 45,186,832;
- 2) the number of fully paid ordinary shares in the Company to be issued on the exercise and conversion of the Options is 45,186,832:
- 3) the exercise price for each Option is \$0.25 each;
- 4) the due date for payment of the exercise price (in cleared funds) is the Expiry Date;
- 5) if payment in cleared funds is not received by the Expiry Date, the Options will expire unexercised and all rights attaching to the Options will cease;
- 6) official quotation of the Options on ASX will cease at close of trading on Thursday, 28 March 2024, being four business days before the Expiry Date;
- 7) the market price of the Company's shares at the close of trading on Friday, 8 March 2024 was \$0.026, being the latest available market price of the Company's shares on ASX prior to the date of this announcement;
- 8) during the three months preceding the date of this announcement:
- the highest market price of the Company's shares on ASX was \$0.087 on 8 March 2023; and
- the lowest market price of the Company's shares on ASX was \$0.013 on 14 January 2024; and
- 9) as at the date of this announcement, there are no underwriting agreements in relation to the Options.
