Cokal's Coal Barges Return to Batu Tuhup and are now Loading Coking Coal for Immediate Delivery. BBM Metallurgical Coal Production set to Ramp-up to Drive Additional Coal Sales

Key Highlights

- **Cokal's coal barges have returned to the Batu Tuhup Jetty and are currently loading coking coal for delivery to PT Risun Wei Shan Indonesia ("Risun") under an existing sales contract (please refer to ASX announcement on 4 April 2024).**
- **Metallurgical coal production from the BBM Mine is ramping-up to drive additional coal sales, with additional mining equipment already arriving at the BBM mine-site.**
- **Two new mining fleets are scheduled to arrive at BBM by the end of April, resulting in a total of five mining fleets operating at BBM.**
