Fox Resources Ltd (**ASX Code: FXR**) ("Company") is pleased to advise that:

REVALUATION OF BUNDABERG EPC 1523

The 31 December 2014 Quarterly Report advised that as part of the June 2014 entitlement offer an independent experts report, including a VALMIN report, was distributed to shareholders, this report contained a range of values for the Bundaberg Project from \$15.5m and \$21.5m with a preferred value of \$17.9m.

The Fox Board has accordingly resolved to revalue the Bundaberg Project at \$15.5m to reflect the VALMIN reports valuation.

EXPLORATION TENEMENTS

The ASX announcement on the 28th August 2015 advised that Fox is reviewing and rationalising its tenement holdings. Fox's exploration strategy is to focus on the Bundaberg Project and the high priority tenements in Western Australia.

Accordingly Fox has relinquished a number of tenements and the updated tenement listing is attached.

Magnetic South has committed to spend \$520,000 on exploration as announced to the ASX on the 30th January 2015 for the Mount Oscar Joint Venture.

Magnetic South has achieved their initial 12% earn-in expenditure, in the Mount Oscar Joint Venture, and this has been registered. Fox Resources Ltd retains an 88% share, in the Joint Venture.

The Osbourne drill target is located within the Mt Marie Joint Venture between Fox Resources and Artemis Ltd; this is a high priority drill target for base metals. Fox Resources has 69.85% and Artemis 30.15% share in the Joint Venture. (Refer ASX release 29 October 2015)

Fox Resources (ASX: **FXR**) is an exploration company with substantial exploration interests in the Queensland Coal region and the Pilbara region of Western Australia.

Fox has outlined a 101Mt Inferred Hard Coking Coal Resource at its Bundaberg Coking Coal Project in southeast Queensland (ASX release 20 March 2014) as well significant Nickel, Copper and Zinc Resources as its extensive package of base metals tenements in the Pilbara region of Western Australia.

The company has previously announced that it has engaged PCF Capital to manage a divestment process of the Bundaberg Coking Coal Project.
