I advise that I was appointed as Voluntary Administrator of the Company on 6 October 2015 pursuant to Section 436A of the *Corporations Act 2001*. A copy of my appointment document lodged with the Australian Securities Investments Commission (ASIC) is attached for your reference.

On 27 August 2015 an application was filed with the Federal Court of Australia's South Australian Registry to wind up the Company. This matter was before the court on 7 October 2015, with Thomson Geer Lawyers attending on the Company's behalf. Thomson Geer Lawyers were successful in obtaining an adjournment of the winding up proceedings until 18 November 2015, the timing of this adjournment will allow the Voluntary Administration to run its full course.

I am currently, with the assistance of the directors, reviewing the Company's financial position and looking at potential avenues for the recapitalisation of the Company or a potential sale of the Company and its business.

As shareholders may be aware on 25 August 2015 all trading of the Company's securities was suspended as a result of non-payment of the Company's annual ASX fee. This suspension will stay in effect until further notice. I note that shareholders will be unable to transfer/dispose of any shares held in the Company during the Administration period without the consent of the Administrator or leave from the Court.

I confirm that I will be complying with the ASX listing rules throughout the course of my appointment, particularly Chapter 3, Rule 3.1 of the ASX Listing Rules (Continuous Disclosure – Immediate Notice of Material Information).

I will be providing further updates in relation to the Company as they become available. All updates will be made available via the ASX website.
