## Scheme Meeting Results

The Directors of MacPhersons Resources Limited (ASX: MRP) are pleased to advise in accordance with ASX Listing Rule 3.13.2 and Section 251AA of the Corporations Act, details of the resolutions and proxies received for the Scheme Meeting held on 31 May 2019.

The resolution approving the Scheme of Arrangement, as set out in the Notice of Scheme Meeting dated 17 April 2019, was passed with the requisite majorities of shareholders with:

1. Greater than 50% of shareholders present in person and voting (in person or by proxy) in favour of the resolution; and
2. Greater than 75% of eligible votes cast in favour of the resolution.

MacPhersons has applied to the Supreme Court of Victoria for approval of the Scheme at a hearing scheduled for 6 June 2019. If the Scheme is approved by the Court, MacPhersons shareholders who hold shares on the scheduled Scheme Record Date, being 5.00pm (WST) on 11 June 2019, will be entitled to receive the consideration of one new Intermin Resources Limited Share for each 1.8227 MacPhersons Shares held.
