The total number of shares currently on issue according to the ASX records is incorrect due to various Appendices 3B not being processed. The Company believes the correct number of shares pre-consolidation is 179,998,454 fully paid ordinary shares. Post consolidation the number of shares is estimated to be 70,000,000 fully paid ordinary shares.
