ALPHA TECHNOLOGIES CORPORATION LTD ACQUIRES MANUFACTURE/ ASSEMBLY AND DISTRIBUTION BUSINESSES

Key Points

- 1. Alpha has now commissioned its own manufacturing factory in China to provide a flexible basis to expand assembly operations.
- Alpha has purchased the intellectual property and associated rights to manufacture and assemble a new product line of anti-bacterial hand sanitisers and hand dryers from Panache Global Holdings Pty Ltd ACN 110 933 858.
- 3. Alpha has also entered into a conditional agreement to acquire the world wide sales and distribution rights to this new anti-bacterial hand sanitiser. The purchase of the sales and distribution rights is subject to approval by Alpha shareholders.
- 4. Richard Harold Rubin who is the CEO of Panache Global Holdings Pty Ltd is to be appointed a Director of Alpha.

New China Factory: Alpha has now completed commissioning and is pleased to announce it has established its own manufacturing factory in China. It is expected this will further reduce Alpha's cost of manufacture and at the same time provide Alpha with greater quality control for the manufacture of its products. The new factory in China also has the capacity to allow Alpha to increase production significantly and expand operations, while at the same time having efficiencies of scale.

Manufacturing rights to Hand Sanitisers: The first project to utilise the expanded manufacturing facilities of the new China factory will be the manufacture by Alpha of a new line of anti-bacterial hand sanitisers and hand dryers for world wide sale and distribution. Alpha has acquired the existing intellectual property rights, prototypes and manufacturing rights for this new line of Hand Sanitisers from Panache Global Holdings Pty Ltd.

The consideration for the acquisition of the Hand Sanitisers manufacturing business is cash of \$855,000 plus the issue of 113 million Alpha shares credited as fully paid. Panache Global Holdings Pty Ltd has agreed to hold 90% of those Alpha shares for at least 12 months.

Proposed acquisition of sales and distribution rights: Alpha has entered into a conditional agreement to acquire the sales and distribution rights for the new line of Hand Sanitisers from Panache Global Holdings Pty Ltd. This proposed acquisition is subject to Alpha shareholder approval and a notice of meeting will be dispatched shortly.

If Alpha shareholders approve of the proposed acquisition of the world wide sales and distribution rights, Alpha will pay Panache Global Holdings Pty Ltd a further cash payment of \$495,000 and issue a further 134,393,905 Alpha shares credited as fully paid.

Retention of Panache Global Holdings Pty Ltd: Where Alpha's shareholders approve the purchase of the sales and distribution rights to the new Hand Sanitisers, Alpha is to retain Panache Global Holdings Pty Ltd to assist in worldwide sales.

The parties have already received interest from two major international customers for the first production run of the Hand Sanitisers. Alpha has engaged an expert in tooling and plant commissioning with the objective of having the production facility in China for the manufacture of the Hand Sanitisers in place by early July 2007.
